The coronavirus (COVID-19) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and can spread from person-to-person contact. The JCC Supplementary Hebrew Schools JRoots and Kachol Lavan holds the health and safety of our children, families and staff as its highest priority and has and will continue to use its best efforts to institute and implement preventative measures to reduce the spread of COVID-19, including but not limited to:

- Preopening and nightly deep sanitization protocols and regular stringent cleaning regimes throughout the day.
- Air vent cleaning.
- Increased number of hand sanitizer dispensers throughout the centre.
- Physical distancing, wayfinding measures, and staggered drop off and pick up times to ensure reduced physical proximity.
- In-depth staff health and safety training and compliance monitoring.
- Screening checks upon entering the facility.
- Appropriate Personal Protective Equipment (PPE).
- Limiting the numbers of people entering the Centre (only essential visitors are permitted, no parents allowed).

Even with all the above preventive measures and more, the JCC Supplementary Hebrew Schools cannot guarantee that you or your child(ren) may not become exposed, infected or otherwise contract COVID-19 while attending, participating in or otherwise engaging in any activities at or in connection with the Schwartz/ Reisman Centre. In consideration of your child entering the Schwartz/ Reisman Centre, please review the facility Code of Conduct and Guidelines below. We appreciate your cooperation in keeping the JCC Supplementary Hebrew Schools JRoots and Kachol Lavan community as healthy as possible and look forward to welcoming you back!

1. HEALTH AND SAFETY

I agree to keep my child home if he/she is ill or anyone in my household has any symptoms related to COVID-19. If your child is away, you will need to inform the school's management of the reason for the absence. Your child can attend JCC Supplementary Hebrew Schools only if he/ she is 24 hours symptom free and has not tested positive for COVID-19. I will inform the school's management if anyone in my household has had close contact with a confirmed or probable COVID- 19 case.

2. TRAVEL

I agree to inform the school's management if my child or I have traveled outside of Ontario Canada or to any places on the COVID-19 Canada travel advisory list within the last 14-days. I understand that according to Public Health Guidelines, my child cannot come to JCC Supplementary Hebrew Schools if the parent/child has travelled outside of Canada, including the United States, within the last 14 days.

3. FACE COVERING

I agree for my child/ren and myself to wear a face mask covering my mouth and nose while in line for the screening area and in the screening area. Face mask covering is mandatory for all students during class sessions at JCC Supplementary Hebrew Schools and in all public spaces, including washrooms.

4. COUGHING/SNEEZING and HAND HYGIENE

As per Public Health Guidelines – I agree to cough into my elbow and cover my mouth and nose when I sneeze. I agree to use hand sanitizer upon entering the facility and to wash my hands frequently or use hand sanitizer while in the Centre.

5. PHYSICAL DISTANCING

I agree to keep 3 meters between myself/my child and others while in the drop-off and pick-up areas as well as in the Centre. I agree to follow all signage and distancing markers posted outside and on the premises.

5. SCREENING

I agree to adhere to screening protocols and to have temperature checks for myself and my child/ren. I understand that the Schwartz/ Reisman Centre and JCC Supplementary Hebrew Schools has the right to deny entry of my child to the school if my child or I fails the screening check.

6. POLICY AND PROCEDURE

I have read and understand the COVID-19 policies and procedures provided by the JCC Supplementary Hebrew Schools and I agree to follow them.

WAIVER OF LIABILITY FROM COVID-19

Please read carefully. This may affect your legal rights.

By signing this waiver and release, I hereby acknowledge and agree that I, on my behalf and on behalf of my child(ren): a) understand the contagious nature of COVID-19; b) voluntarily assume the risk that me, my child(ren) or anyone for whom I am responsible may become exposed, infected, or otherwise contract COVID-19 while attending, participating in or, otherwise engaging in any activities at or in connection with the Schwartz/Reisman Centre and JCC Supplementary Schools and c) hereby waive, release and discharge the Schwartz/Reisman Centre, JCC Supplementary Schools, UJA Federation and its subsidiaries, their employees, agents, operators, directors, officers, volunteers, and independent contractors ("Releasees") from any liability, claims, damage or injuries arising from exposure to, or

contracting, COVID-19 while at the Schwartz/Reisman Centre.
